- -All tires to be re-treaded must meet the following criteria:
- -All old patches must be removed and replaced.
- -All tires must carry a workmanship and material warranty for a minimum of fifty-three (53) weeks.
- -All tires must carry a road hazard warranty for a minimum of twenty-eight (28) weeks.
- -All treads must be conformed to width of casing as per industry standards.
- -All casing must be repaired with proper repair and/or procedures per industry standards.
- -All **casings** to be visually inspected, graded, and capped with appropriate treads as specified by Texas County.
