**RETREAD OF TIRE**

**SIX-MONTHS BID: August 14th, 2021 Through February 14, 2022**

**-All tires to be re-treaded must meet the following criteria:**

**-All old patches must be removed and replaced.**

-All tires must carry a workmanship and material warranty for a minimum of fifty-three (53) weeks.

-All tires must carry a road hazard warranty for a minimum of twenty-eight (28) weeks.

-All **treads** must be conformed to width of casing as per industry standards.

-All **casing** must be repaired with proper repair and/or procedures per industry standards.

-All **casings** to be visually inspected, graded, and capped with appropriate treads as specified by Texas County.

-All **casings** are to be picked up, re-treaded and returned to Texas County on a weekly basis.

-All **casings** returned as received to Texas County with reject code number and explanation of rejection.

-Monthly reports defining number of tires **re-treaded, adjusted, and rejected** must be returned to Texas County with explanation in writing.

-Adjustment credits to be issued to Texas County within seven working days.  
Radial + must be at least 17.5/32 deep, and High Speed must be at least 12/32 deep.
