(1%) sales tax, and ending on the last day of June, 2039; upon the gross proceeds or gross receipts derived from all sales and services in Texas County under the Oklahoma Sales Tax Code, including but not limited to certain enumerated sales and services listed in the Oklahoma Sales Tax Code; for the general operation and capital improvements of the Texas County Sheriff's Office, Rural Emergency Services for ambulance, fire protection, 911 and law enforcement and emergency services, Memorial Hospital of Texas County Free Fair; as specified in Resolution 185-22-23 on file with the County Clerk of Texas County?

Section 2: That such call for said election shall be by Notice of Election attached hereto and approved hereby to be signed by the Chairman of the Board of County Commissioners of Texas County, State of Oklahoma, and attested by the County Clerk, setting forth the Proposition to be voted upon and the hours of opening and closing the polls; that the ballots shall set forth the Proposition to be voted upon substantially as set out in Section 1 hereof; and that the returns of said election shall be made to canvassed by the Texas County Election Board.

(If the voter desires to vote for the above Proposition, he or she shall stamp an "X" in the first Square, #1 above; if the voter desires to vote against the above Proposition, he or she shall stamp an "X" in the second square, #2 above).

Said special election shall be held at the same places and in the same manner prescribed for the conduct of state and county elections and the polls shall be opened at 7:00 o'clock A.M. and remain open continuously until and be closed at 7:00 o'clock P.M. on August 8, 2023.
