**Whereas;** By virtue of this resolution, it is hereby resolved that **Resolution # 206-24-25**, dated **March 25, 2025**, and any and all its subsequent renewals is no longer in effect.

**NOW THEREFORE BE IT RESOLVED:** Conditions will continue to be monitored and if the need arises, the County Burn Ban will be re-instated at a Special or Regular meeting called by the Board of County Commissioners.
