## Reimbursement to Election General Fund **Personal Service Account**

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF TEXAS COUNTY, STATE OF OKLAHOMA:

THAT WHEREAS, based upon the IRS regulations, the State Auditor's Office recommends changes in certain compensation procedures as required by the Fair Labor Standards Act.

THAT WHEREAS, the change states all County Election Board staff who work extra hours or travel in connection with school, municipal, or special purpose districts; County Election Board Members who attend meetings in connection with federal, state, school, municipal, or special purpose districts or meetings for administrative purposes; or other election workers working part-time hours for any election may not be compensated as contract labor and are to be compensated as a part of the regular monthly payroll process.

THAT WHEREAS, the Election Board Secretary shall bill the entity for whom an election was conducted for the amount of overtime, part-time compensation, travel, board meeting compensation, and employer's share of Social Security. Overtime compensation shall be claimed even if it is the county's policy to give compensatory time to county employees for overtime hours worked.

THAT WHEREAS, the Election Board Secretary shall issue a voucher from the Special Depository Account in the amount of the overtime compensation, part-time compensation, travel, board meeting compensation, and employer's share of Social Security withholdings for Precinct Officials, Absentee Voting Board Members, and County Election Board Members, for deposit to the County Election Board General Fund account.

THAT WHEREAS, the Election Board Secretary also bills entities for whom an election is conducted for miscellaneous election supplies, such as postage, paper supplies, copy fees, etc.

**THAT WHEREAS**, the Election Board Secretary shall issue a voucher from the Special Depository Account in the amount of the miscellaneous reimbursements for deposit to the County Election Board General Fund account.

AND WHEREAS, the terms of this resolution shall commence on July 1, 2025, and end June 30, 2026, and shall be renewed annually by resolution on or before the 1<sup>st</sup> day of July.

NOW, THERFORE, BE IT RESOLVED that the Texas County Board of County Commissioners direct the County Treasurer to reimburse the County Election Board Personal Services, Part-time Help, Travel, or Maintenance & Operations General Fund Account pursuant to Title 62, Section 335, of the Oklahoma Statutes.

A RESOLUTION OF COMPLIANCE WITH THE OKLAHOMA OPEN RECORDS ACT AND ESTABLISHING FEES AND PROCEDURES IN ACCOURDANCE WITH THAT ACT.

WHEREAS, THE 1985 Senate Bill 276 and the 2019 Senate Bill 0003 (Oklahoma Open Records Act) requires public bodies to keep and maintain certain records for public inspection and reproduction;

WHEREAS, the public body may establish fees under this act to recover the direct cost of document search and establish reasonable procedures which protect the integrity and organization of its record and to prevent excessive disruption of its essential functions;

NOW THEREFORE, BE IT RESOLED, by the Board of County Commissioners of Texas County, the following fees and procedures shall apply;

- 1. Person(s) designated in the County Clerk's Office as authorized to release records of the public body for inspection, copying or mechanical reproduction shall be:
  - a. Wendy Johnson
  - b. Alisha Perez
  - c. Kelly Voorheis

At least one such person shall be available at all times to release records during the regular business hours of the public body, or to designate a time which shall be reasonable prompt, but not to excessively disrupt the essential functions of the entity;

- 2. A document search shall be made at a time specified by the person(s) designated as authorized to release records. This shall be done promptly, but not to excessively disrupt the essential functions of the entity.
- 3. Fees for the mechanical reproduction of records open for public inspection in accordance with the Open Records Act shall be as follows:
  - 1. Paper copies of records 8 1/2" X 11" @ \$1.00 per page;
  - 2. Paper copies of records 8 1/2" X 14" @ \$1.00 per page;
  - 3. Electronic Imaging .25¢ per image up to 3500 images and .15¢ over 3500 images;
- 4. Any and all other records available as per the Open Records Act shall be on direct cost of time and material basis, not to exclude fees for document search.

- 5. Records requested;
- 6. Form in which records are requested;
- 7. Total fees paid to public body for records provided;
- 8. Signature of person making request, declaring they have received the information.

The person making such request shall provide adequate identification to substantiate the information provided on the request form.

The request form information form shall become part of a permanent record kept on file in the office of the County Clerk and

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF TEXAS, STATE OF OKLAHOMA, APPROVING THE ENTRANCE INTO THE INTERLOCAL AGREEMENT ESTABLISHING THE OKLAHOMA COOPERATIVE LIQUID ASSETS SECURITY SYSTEM (OKLAHOMA CLASS') WITH OTHER GOVERNMENTAL PARTICIPANTS FOR THE PURPOSE OF EXERCISING INVESTMENT POWER JOINTLY TO INVEST FUNDS IN CONCERT WITH OTHER PARTICIPANTS PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF TEXAS, Oklahoma (the "County") is permitted and has the power pursuant to the provisions of the Oklahoma Interlocal Cooperation Act, Title 74 Oklahoma Statutes Section 1001 *et seq.* to enter into interlocal agreements to exercise jointly with any other governmental entities any power, privilege, or authority which such governmental entities share in common and which each might exercise separately; pursuant to a written interlocal agreement; and

WHEREAS, interlocal agreements may be created so that units of local government may invest certain of their funds in statutorily permitted investments including but not limited to any intergovernmental investment pool authorized pursuant to Title 62 Oklahoma Statutes Section 348.1(A)(6); and

WHEREAS, the County, from time to time, has funds on hand in excess of current need; and

WHEREAS, it is in the best interest of the COUNTY and its residents to invest funds in investments that yield a favorable rate of return while providing the necessary liquidity and protection of the principal; and

WHEREAS, the County desires to enter as a Participant (as such term is defined in the Interlocal Agreement) into the Interlocal Agreement establishing Oklahoma CLASS, a copy of which is attached hereto as Exhibit "A" (the "Interlocal Agreement") in order to exercise investment power jointly and in concert with the other Participants pursuant to the Interlocal Agreement as authorized by the Oklahoma Interlocal Cooperation Act in order to take advantage of economics of scale and perform governmental functions more efficiently; and

WHEREAS, the policy of the Interlocal Agreement shall be to place the highest priority on the safety of principal and liquidity of funds, and the optimization of investment returns shall be secondary to the requirements for safety and liquidity;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF TEXAS, STATE OF OKLAHOMA, AS FOLLOWS:

**SECTION 1.** The County hereby joins the Interlocal Agreement as a Participant and agrees to be bound by all the terms and provisions thereof.

**SECTION 2.** The Chairman is hereby authorized to execute the Interlocal Agreement, the Instrument of Adoption, and such other documents, certifications, representations, or agreements as may be necessary or convenient to affect the foregoing.

**SECTION 3.** The Treasurer of the County is hereby directed to make such amendments as may be necessary to the County's written investment policies to permit the investment of County fund, at the Treasurer's discretion, in Oklahoma CLASS as authorized pursuant to Title 62 Oklahoma Statutes Section 348.1(A)(6).

**SECTION 4.** Aimee Midkiff, Texas County Treasurer is hereby designated as the "Key Contact" (as defined in the Policies and Procedures of the Participants) and vested with the power to transfer funds for investment to Oklahoma CLASS, to withdraw funds from Oklahoma CLASS from time to time, to issue letters or other indications of instructions, and to take all other actions necessary to carry out the investment of County funds in Oklahoma CLASS.

**SECTION 5.** The COUNTY approves the establishment of an account or accounts in its name in Oklahoma CLASS for the purpose of transmitting funds for investment, subject to the Investment Policies established by Oklahoma Class, and the COUNTY acknowledges that it has received a current copy of said investment policies.

**SECTION 6.** Notices from Oklahoma CLASS related to the COUNTY's accounts and investments shall be provided to Aimee Midkiff, Texas County Treasurer.

SECTION 7. This Resolution and the authorizations contained herein shall continue in full force and effect until amended or revoked by the COUNTY until amended or revoked by subsequent

action by the BOARD OF COUNTY COMMISSIONERS and until Oklahoma CLASS receives a copy of such amendment or revocation Oklahoma CLASS is entitled to rely upon the same.
