Wadley reported that there is no need for a burn ban at this time. We have had several grass fires. It was mentioned at a conference how great Texas County Commissioners and the Fire Departments work together on wild land fires. They wished that other counties would do the same. There is some legislature going in for next year about the burn ban rules and giving the Commissioners more leeway to put a burn ban in place, the tribes are backing it also.
