Re: Notice of Non-Gaming Land Acquisition Application

To Whom It May Concern:

We are writing today in response to the Shawnee Tribe's recent request to have a specific parcel of land within our county declared as tribal land. While we deeply respect and understand the cultural and historical importance of this action, we would like to share a concern that affects the operational health of our county and the families we serve.

As a public entity, we rely heavily on ad valorem property tax revenues to fund essential services and staffing. The specific parcel in question currently generates approximately \$8,400 in ad valorem annually – funds that directly support our school and county.

A change in the tax status of these lands would create a permanent shortfall in our already tightly managed budget. While \$8,400 may seem modest in a broader context, every dollar matters in our efforts to maintain a high standard of services to our citizens.

We respectfully request that the Shawnee Tribe consider the impact this reclassification would have on our citizens and our schools, particularly those from underserved communities who rely most heavily on the services these funds help support.

The District Attorney was not present.




