This harm was created and exacerbated by the misconduct and illegal activities of pharmaceutical manufacturers, including Purdue Pharma L.P. and its related entities ("Purdue"), and Sackler family members as officers, directors, managers, and shareholders of Purdue (the "Sacklers").
- WHEREAS, the County of Texas, Oklahoma has claims against Purdue and/or the Sacklers, and has filed suit to address and seek recovery for the harms caused to Texas County, Oklahoma and its citizens.
- WHEREAS, Purdue and the Sacklers have agreed to settle claims of political subdivisions in the Purdue bankruptcy plan (the "Plan"), the Governmental Entities Settlement Agreement ("GESA") dated June 17, 2025, and the Purdue State-Subdivision Agreement.
- **THEREFORE**, it was duly moved and seconded that the following resolution be adopted.
- THEREFORE, BE IT RESOLVED that the County of Texas, Oklahoma hereby acknowledge receipt of the Disclosure Statement for Thirteenth Amended Joint Chapter 11 Plan of Reorganization of Purdue and Its Affiliated Debtors, and that it has been informed of the material aspects of the Plan relative to its claims against Purdue and its affiliated entities.
- THEREFORE, BE IT RESOLVED, that the County of Texas, Oklahoma hereby elects to participate in and approves its participation in the Plan, authorizes its attorneys to

vote on its behalf for approval of the Plan, and ratifies any such vote submitted via master ballot or otherwise.

THEREFORE, BE IT RESOLVED, that the county of Texas, Oklahoma authorizes the Texas Board of County Commissioners to execute the GESA Participation and Release Form, as contained in Exhibit K of the GESA, either electronically via DocuSign or in paper form, and agrees to the terms set forth therein, including the release of and/or dismissal with prejudice of the County's claims as provided in the Participation Form.

THEREFORE, BE IT RESOLVED, that County of Texas, Oklahoma, further authorizes its Board of County Commissioners and legal counsel to take all actions required by the Plan or the GESA, and Purdue State-Subdivision Agreement, for the benefit of the County of Texas, Oklahoma, including executing any documents required to finalize the participation of the County of Texas, Oklahoma in the Plan and GESA, and Purdue State-Subdivision Agreement.

(Docket Nos. 4380 and 4670) (Collectively, all nine settling generic opioid manufacturers referred to herein as "Settling Defendants").

- WHEREAS, the County of Texas, Oklahoma has claims against Alvogen, Amneal, Apotex, Hikma, Indivior, Mylan, Sandoz, Sun, and Zydus, and has filed suit to address and seek recovery for the harms caused to Texas County, Oklahoma and its citizens.
- WHEREAS, the Settling Defendants have offered to settle claims of Texas County, Oklahoma in the Settlement Agreements of generic opioid manufacturers Alvogen, Amneal, Apotex, Hikma, Indivior, Mylan, Sandoz, Sun, and Zydus dated April 04, 2025.

THEREFORE, it was duly moved and seconded that the following resolution be adopted.

- THEREFORE, BE IT RESOLVED that the County of Texas, Oklahoma hereby acknowledges receipt of and been informed of the material aspects of the Settlements relative to its claims against generic opioid manufacturers Alvogen, Amneal, Apotex, Hikma, Indivior, Mylan, Sandoz, Sun, and Zydus.
- THEREFORE, BE IT RESOLVED, that the County of Texas, Oklahoma hereby elects to participate in and approves its participation in the Settlement Agreements, authorizes the Texas Board of County Commissioners to execute all Participation and Release Forms, as contained in Exhibit K of the Settlement Agreements, either electronically via DocuSign or in paper form, and agrees to the terms set forth.
