INTERLOCAL AGREEMENT

Now on this 13th day of May, 2019, the CITY OF GUYMON, OKLAHOMA (The City) and the BOARD OF COUNTY COMMISSIONERS OF TEXAS COUNTY, OKLAHOMA (The County) in consideration of the mutual promises herein do execute this agreement.

WHEREAS, the City and County each recognize the benefits to the residents of the county which result from development of recreational and sports facilities; and

WHEREAS, the City is making available real property for the development of a sports complex including soccer facilities (facilities) which will be available for use by soccer teams from schools from towns, cities and communities in Texas County; and

WHEREAS, the City and the County have agreed to cooperate and share some of the expense in development of the sports facilities.

NOW THEREFORE, in consideration of the mutual promises herein contained, the parties do agree as follows:

- 1. **BENEFITS:** The recreational and economic benefits to the City and the County from development of the facilities will be substantial. The facilities will be available for use by area schools, organizations and the Oklahoma Panhandle State University soccer program. The facilities will be available for soccer tournaments involving teams from communities in the Oklahoma Panhandle and from other states adjoining the Oklahoma Panhandle.
- 2. FUNDING: Funds received and pledged to development of the facilities exceed four Million Dollars (\$4,000,000.00) as a result of fund raising activities of the City. County agrees to share some expense of the project by providing preliminary dirt work including rough site grading and shaping services.

- **3. DURATION:** The duration of this agreement is sixty (60) days from the date the County begins its work.
- 4. **PURPOSE:** The purpose of this agreement is to allow the County to contribute consideration for benefits to the County which will result from the development of the facilities for the benefit of county residents.
- **5. SUPERVISION:** Supervision of the County's performance of this agreement shall be conducted by representatives of the County and the City.
- 6. LOCATION: The facilities will be located on State Highway 3 and US Highway 412 with access from the towns of Texhoma, Goodwell, Hardesty, Optima and the City of Hooker, Oklahoma.
