#### COUNTY COMMISSIONER BURN BAN RESOLUTION

The Texas County Board of County Commissioners pursuant to the authority granted to the Board by Section 16-26.B of Title 2 of the Oklahoma Statutes, do hereby proclaim that extreme fire danger exists in Texas County. This situation (as defined in Section 16-26.B. 1. a-d, Title 2, O.S.) has been verified by a documented concurrence of the majority of the County's municipal and rural fire chiefs, or their designees.

By virtue of this resolution, it is unlawful for any person to set fire to any forest, grass, range, crop or other wild lands, or to build a campfire or bonfire, or to burn trash or other material that may cause a forest, grass, range, crop, or other wild lands fire.

Exceptions and the appropriate precautionary measures to be taken are as follows:

# FOR EQUIPMENT RELATED TO ROAD CONSTRUCTION PROJECTS:

Equipment which uses propane or other controlled-type burners is generally regarded as safe, however it would be prudent to have a water pumper standby anytime this equipment is used near a grassy right-of-way.

#### WELDING/CUTTING TORCH/GRINDING ACTIVITIES:

- 1. When conducted over non-combustible surface of at least 10 feet by 10 feet and when welding blankets or screens are used to cover flammable vegetation; and
- 2. Wind speeds must be less than 20 mph; and
- 3. A fire watch, other than the welder, is posted at the welding/cutting torch site with pressurized water or fire extinguisher.

## **CAMPFIRES AND OUTDOOR COOKING:**

Outdoor campfires or bonfires are prohibited, LPG and natural gas grills and charcoal-fired cooking outside in a grilling receptacle are permitted provided that the activity is conducted over a non-flammable surface and at least five feet from flammable vegetation.

Enforcement of this resolution may be carried out by any law enforcement officer of this State. Any person convicted of violating this resolution shall be guilty of a misdemeanor and shall be subject to a fine of not more than Five Hundred Dollars (\$500.00), to imprisonment for not more than one (1) year, or to both such fine and imprisonment.

This resolution shall be effective immediately for a period not to exceed <u>14</u> days from the date of passage by the Texas County Board of County Commissioners. If extreme fire danger conditions persist, subsequent resolutions may be passed. This Burn Ban may be removed at any time during the thirty- day period by the same method by which it was approved.

## **RESOLUTION 207-19-20**

WHEREAS, the Governor has previously issued a statewide Order that imposed restrictions on business activities, stay-at-home requirements, personal spacing distances, and other measures related to addressing the COVID-19 pandemic and current health crisis in the State of Oklahoma, and has announced modifications to his previous Orders easing restrictions on certain businesses and individual activities due to a perceived statewide decline in hospitalizations due to COVID-19 infections;

WHEREAS, the County Commissioners believe that each area in the State of Oklahoma is subject to different conditions and circumstances that must be carefully assessed with respect to easing of the restrictions on business and personal activities that should be maintained in order to adequately and properly promote the safety of the citizens within each area of the state, and

WHEREAS, Texas County has been experiencing a significant increase in the number of persons having been confirmed to be infected with the COVID-19 virus, and that it appears that a serious threat of the spread thereof within Texas County remains extremely high;

IT IS THEREFORE RESOLVED that the Texas County Courthouse should and will remain subject to restricted access by the public until further action of the Commissioners which will be reviewed on a weekly basis.

IT IS FURTHER RESOLVED that the citizens and businesses of Texas County should continue to exercise extreme caution with respect to public and business activities, especially those involving personal contacts with the public. All businesses are strongly encouraged to implement policies and practices that will insure to the maximum extent possible that persons entering their businesses are afforded recommended personal spacing and other protection such as face coverings from other persons as well as employees. Individuals are also encouraged to limit public activity and personal contacts in the public to the maximum extent possible. Non-essential public gatherings continue to be discouraged, and when necessary, personal spacing and other measures to protect all person's present should be implemented.

IT IS FURTHER RESOLVED that due to the Commissioners not having regulatory authority that each City and Town within Texas County consider and take appropriate measures to further protect the health, safety and welfare of the citizens of Texas County.
