(collectively "Janssen").

WHEREAS Texas County filed suit to address and seek recovery for the harms cause to it and its citizens.

WHEREAS, Janssen has agreed to settle the claims of certain Oklahoma Participating Subdivisions in the Janssen Oklahoma Subdivision Opioid Settlement Agreement.

THEREFORE, BE IT RESOLVED that Texas County, Oklahoma hereby elects to, and approves its participation in , the Janssen Oklahoma Subdivision Opioid Settlement Agreement, authorizes its Board of County Commissioners, to execute the Settlement Participation Form contained in the Janssen Oklahoma Subdivision Opioid Settlement Agreement as Exhibit C, and authorizes its counsel to take all actions required by Exhibit C and the Janssen Oklahoma Subdivision Opioid Settlement Agreement to effectuate the Janssen Oklahoma Subdivision Opioid Settlement Agreement for the benefit of Texas County, Oklahoma.
