#### RENEWAL OF TEXAS COUNTY BURN BAN

Whereas; The Texas County Board of Commissioners pursuant to the authority granted to the Board by Section 16-26. B of Title 2 of the Oklahoma Statutes, do hereby proclaim that extreme fire danger exists in Texas County. This situation (as defined in Section 16-26.B1.a-d, Title 2, O.S.) has been verified by a documented concurrence of the majority of the County's municipal and rural fire chiefs, or their designees.

Whereas; By virtue, if this resolution, it is unlawful for any person to set fire to any forest, grass, range, crop, or other wildlands, or to build a campfire or bonfire, or to burn trash or other material that may cause a forest, grass, range, crop, or other wildland fire. All outdoor burning in progress at the time of the passage of this resolution are ordered to be fully extinguished immediately by the property owner or his/her designate. Controlled burns or other activities stated herein which have occurred prior to the passage of this resolution and are ongoing at the time of this resolution shall not be a defense for violation of this resolution.

Whereas; Any law enforcement officer of the State of Oklahoma may carry out the enforcement of this resolution. Any person convicted of violating this resolution shall be guilty of a misdemeanor and shall be subject to a fine of not more than Five Hundred Dollars (\$500.00), to imprisonment of not more than one (1) year, or to both such fine and imprisonment.

Whereas; Certain exceptions may be attached to this resolution by Texas County.

**EXCEPTIONS:** Exceptions may be authorized as checked below:

## \_\_NO EXCEPTIONS ARE GRANTED TO THIS BURN BAN

X FOR EQUIPMENT RELATED TO ROAD CONSTRUCTION PROJECTS
Equipment which uses propane or other controlled type burners is generally regarded as safe, however it will be required to have a water pumper on standby any time this equipment is used near a grassy right-of-way. Such requirement is the responsibility of the company or organization conducting the construction, and is not the responsibility of the fire department within the jurisdiction in which the construction activities are taking place.

## X WELDING/CUTTING TORCH/GRINDING ACTIVITIES

When, conducted over a non-combustible surface of at least 10 feet by 10 feet and When welding blankets or screens are used to cover flammable vegetation, and;

- 1) Wind speeds are less than 20 m.p.h., and;
- 2) A fire watch, other than the welder, is posted at the welding/cutting torch site with pressurized water or a fire extinguisher.

### X CAMPERS AND OUTDOOR COOKING

Outdoor campfires or bonfires are prohibited. LPG and charcoal-fired cooking outside in a grilling receptacle are permitted, provided that the activity is conducted over a non-flammable surface and at least five feet from flammable vegetation.

NOW THEREFORE BE IT RESOLVED: That the Texas County Board of Commissioners made this COUNTY WIDE BURN BAN EFFECTIVE IMMEDIATELY for a period not to exceed fourteen (14) days from the date of passage by the Board of County Commissioners. If extreme fire danger conditions persist, subsequent resolutions may be passed. This Burn Ban may be removed at any time during the fourteen-day period by the same method by which it was approved and may be overridden at any time by a lawfully declared Burn Ban by the Governor of the State of Oklahoma.

Ermann: In the last meeting we put in a request for ARPA Funds, and I think it is still being reviewed to see if it qualifies, is that still the situation?

Keeling: Yes, it does qualify. The reason we are here today is to bring you up to date on 911, the Ambulances, County Clerk, Fire Departments, we are currently working to see what our balance is. It doesn't look like we are going to be able to come up with that full amount. We are in the process of getting that money incumbered and see exactly where we are at and I don't think we are going to be able to do the full amount for Emergency Room. As I expressed in our meeting the .45% Sales Tax is tight right now along with the other accounts. We are committed to do what we can repair the building where we can. We are still looking at a way of fixing the MRI. Those decisions can't be made here, they will be made in an open meeting with us once we go through our numbers and see what we can do or can't do. I want everyone to know we are 100% on board with saving this hospital within our means. As of July 2022, we have already given the hospital \$1.8 million. To say the County doesn't care... we do. We have a lot of Emergency Services in the County to take care of also. We will continue to look and listen to all of your requests but there is a level to what we can do without hurting the rest of our Emergency Services. I have heard nothing but compliments on the Emergency Room, and the job they are doing. AC going out, we approved to take care of that in March but some confusion on communications about who was doing what. Hopefully, the communications get better so we can better serve you guys. Wendy has been a big help to us and helps you all order stuff but as far as the maintenance and stuff, that's your deal. You let us know what we need to do, and we will do it within our means. We are going to help as much as we can but just like everybody else, we have to look at all our services. I hear comments that the County Commissioners don't care. Since January of 2007 I have been watching this hospital struggle and come back. We are here to serve this board on how the hospital operates to the best of our ability. We have time to say this

is where we can get to what can we do to hold on until we can afford to get there. That's just my opinion, I'm not speaking for the other two. We all need to work together to keep this hospital open. We all know how valuable it is. In the past month I know for a fact that this Emergency Room has saved three lives that I know of, so my hats off to them. That is one thing we have got to have no matter what. Let's all continue to communicate and work together. I have seen the deal between the doctors and the hospital, and we all need to find a way to work together. It takes all of us working together to make this work. Please everybody show a little respect and try to understand where everybody else is coming from. Jack has sat there just like I have. Believe me he is sitting on this board because he cares. We have been fighting for this hospital for years and we are going to continue fighting for it, but we all have a limit. If you guys get back with us Monday, we will have you on the agenda again. We will be more than happy to look and see what we can do, we should have our numbers by then and we can see what we can do to repair the MRI. Thank you.

Ermann: If we get the MRI running and do away with the lease, we will still have about \$1,000,000.00 shortage. So, we would still need \$83,000.00 a month. If the County doesn't have the funds for operations, then we need to change our strategy. We have growth in most areas. I need to know what route we are going to take. I need to know as soon as possible.

Bickford: Ted did a pretty good job. We will give everything we can give. The only other thing on the table for us is to completely and totally forsake all of the other entities that have needs.

Ermann: If you would like I can look at where we can cut costs and revenues to see where we can get to. There is a Rural Emergency Health, that means you provide Emergency Room Labs, and Imaging Services. Commissioners came to tour the hospital.

Keeling: I appreciate the guys taking us around and showing us the things that have been fixed and the problems that are still out there in the older parts of the building that are not being used. I had comments on stuff on the roof. It's going to be an ongoing effort to keep this building up. We will do our best to keep up with it. We all know it takes money to make money. We need to grow services and hopefully we can continue with that and pace it out.

Sledge: If you don't mind, I did see a few things when we took the tour and I appreciate that. There were some things I saw that need to be addressed that might help the compressor issues. The fins are bent and that is a simple fix. If we could do some preventive maintenance could help in the future. The drainpipes not being hooked up and leaking on the roofs, things like that.
