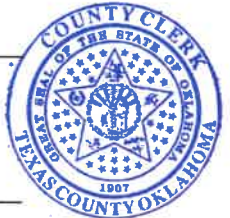
AND, upon proper and careful consideration, find that the above equipment is obsolete and not economical to continue to use for county purposes.
