

**RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS IN AND FOR TEXAS COUNTY OKLAHOMA APPROVING ASSESSMENT AND COLLECTION BY THE TEXAS COUNTY COURT CLERK OF TEN DOLLARS (\$10.00) PER CIVIL CASE FILING AS PROVIDED BY SB456 (Effective November 1, 2015 and codified at 28 O.S. Supp. 2015§152(F) FOR USE BY THE TEXAS COUNTY SHERIFF FOR ENHANCED COURTHOUSE SECURITY.**

**WHEREAS**, THE Oklahoma Legislature enacted SB456 during the 2015 session, which provides that this Board may approve assessment and collection by the Texas County Court Clerk of a sum not to exceed Ten Dollars (\$10.00) per civil case filing (as defined by statute) the purpose of enhancing and/or providing additional courthouse security, and;

**WHEREAS**, THE Texas County Sheriff has requested that this Board authorize the collection of the full Ten Dollars (\$10.00), and he has discussed the matter with the Texas County Court Clerk who concurs that the fee is authorized and necessary, and ;


**WHEREAS**, if approved the fee shall be credited to the Sheriff's Courthouse Security Fund/Sheriff Courthouse Security Cash Account in the county in which the action arose; and used specifically for " the purpose of enhancing existing or providing additional fee is both necessary and appropriate.

**NOW THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF TEXAS COUNTY, OKLAHOMA THAT:**


1. That the sum of Ten Dollars (\$10.00) shall be and the same is hereby assessed and shall be collected for each civil case filed under Title 28 Section 152 paragraphs 1, 3, 8, 9, 10, and 14 of subsection A of this section in the District Court of Texas County, Oklahoma for the purpose of enhancing existing or providing additional courthouse security for the Texas County Courthouse.
2. That all sums collected as a result of such assessment shall be credited to the Sheriff's Courthouse Security Fund/Sheriff Cash-4CHS Account to be used for the purposes stated herein.
3. Collection of the sum assessed herein shall commence on November 1, 2015.
4. Upon its passage and adoption, a certified copy of this resolution shall be provided to the Texas County Court Clerk.
