A RESOLUTION APPROVING AN INFORMAL INTERLOCAL AGREEMENT BETWEEN THE CITY OF GUYMON AND TEXAS COUNTY FOR CONSTRUCTION, RECONSTRUCTION AND IMPROVEMENT OF PUBLIC ROAD NO. 32, ALSO KNOWN AS HURLIMAN ROAD.

WHEREAS, the Board of County Commissioners of Texas County, Oklahoma has considered execution of an informal interlocal agreement with the City of Guymon for construction, reconstruction and improvement of Public Road No. 32, also known as Hurliman Road, Texas County, Oklahoma.

**INFORMAL INTERLOCAL AGREEMENT FOR CONSTRUCTION,
RECONSTRUCTION AND IMPROVEMENT OF PUBLIC ROAD NO. 32**

This Interlocal Agreement is entered into between the City of Guymon, Oklahoma, (City) and the Board of County Commissioners for Texas County, Oklahoma, (County) pursuant to the Interlocal Cooperation Act, 74 O.S. §§1001 et seq., and shall be effective immediately upon the approval hereof by City of Guymon and the County Commissioners of Texas County. This Interlocal Agreement is being entered into as an "informal agreement" pursuant to § 1008 of the Interlocal Cooperation Act, and shall not require the approval of the Oklahoma Attorney General.

In consideration of the mutual promises herein contained, the parties do agree as follows:

1. **Purpose.** The purpose of this agreement is to jointly provide for construction, reconstruction and improvement of public road no. 32 also know as Hurliman Road beginning at its intersection with U.S. Hwy 54 and continuing North a distance of approx 1 1/4 miles to Road T, in Texas County, Oklahoma. It is not the purpose or intention of the parties to this cooperative agreement to hereby create or establish a separate legal entity.
2. **Term.** The term of this agreement shall begin August _____, 2015 and end NOVEMBER 1st, 2015 or upon the earlier completion of the construction of said public road.
3. **Management.** The County, by and through the County Commissioners, shall act as the administrator of this agreement and serve as the agent for the City of Guymon for the purposes of this agreement.
4. **Duties of Texas County.** The County shall be responsible for compliance with the Oklahoma Competitive Bidding act, management and supervision of construction of said public road and payment of one-half (1/2) of the cost of said construction as herein provided.
5. **Cost of Construction.** The parties estimate the costs of construction of said road shall be \$ 395,000 and said costs shall be paid one-half (1/2) by the County and one-half (1/2) by the City at such time and in such amounts as become due and payable under the terms of the construction contract.
6. **Duties of the City.** The City shall pay one-half (1/2) of the cost of construction of said road. The City shall consult with the County at such times as the parties may agree. The public works director of the City shall be available for consultation with the County representative upon construction matters or issues.

7. **No Property To Be Acquired.** No real or personal property will be acquired under or pursuant to this cooperative agreement.

8. **Effective Date.** This agreement shall become effective upon approval of the Board of County Commissioners of Texas County and the Guymon City Council.

9. **Amendment.** This agreement may be amended only in writing any by agreement of the parties.
