A RESOLUTION APPROVING THE EXECUTION OF A GROUND LEASE AGREEMENT BETWEEN INDEPENDENT SCHOOL DISTRICT NO. 61 OF TEXAS COUNTY, OKLAHOMA (TEXHOMA PUBLIC SCHOOLS) AND THE TEXAS COUNTY DEVELOPMENT AUTHORITY AND A LEASE/PURCHASE AGREEMENT BETWEEN SAID AUTHORITY AND SAID SCHOOL DISTRICT; AND CONTAINING OTHER PROVISIONS RELATING THERETO.

WHEREAS, the Texas County Development Authority (the "Authority") did, by its Resolution adopted on January 21, 2013, authorize the execution of a Ground Lease Agreement (the "Ground Lease"), by and between Independent School District No. 61 of Texas County, Oklahoma (Texhoma Public Schools) (the "School District"), as lessor, and the Authority, as lessee, and a Lease/Purchase Agreement (the "Lease/Purchase Agreement"), by and between the Authority, as lessor, and the School District, as lessee, which are to be used in conjunction with a lease financing of the School District (the "Lease Financing"), the proceeds of which are to be used for the following purposes: (i) finance certain educational facilities to serve the students of the School District and residents of Texas County, Oklahoma (the "County"); and (ii) pay certain costs of issuance;

WHEREAS, the Board of County Commissioners hereby determines that the actions taken by the Authority should be authorized and approved.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF TEXAS COUNTY, OKLAHOMA:

SECTION 1. Execution of Documents Authorized. The Texas County Development Authority is hereby authorized to execute the Ground Lease and the Lease/Purchase Agreement in regard to the Lease Financing of the School District, provided that said Lease Financing shall never constitute a debt of either the Authority or Texas County, Oklahoma.

SECTION 2. Incidental Action. That all actions heretofore taken by the Authority in connection with the issuance, sale and delivery of the Lease Financing for the School District, and all other aspects of the transaction be and are hereby authorized, approved and ratified. Furthermore, the Chairman of the Board of County Commissioners and County Clerk be and hereby are authorized and empowered to execute and deliver for and on behalf of the County any and all documents or instruments reasonably necessary to accomplish the issuance, sale and delivery of the Lease Financing and all other aspects of the transaction by the Authority.
