RESOLUTION FOR APPROVAL OF UTILITY PERMITS RESOLUTION # 15-04-05

WHEREAS, the Statutes of the State of Oklahoma (OKLA. STAT. tit. 18, §437.2 and 438.4 (1991) and OKLA. STAT. tit. 69, § 1401 (1991) provide that rural electric cooperatives, telephone cooperative corporations and public utilities shall have the right-of-way and all easements pertaining thereto for the purpose of erecting poles and posts, attaching equipment, wires and fixtures thereto and laying lines, pipes and conduits under the surface thereof.

WHEREAS, <u>PTCI</u> has requested this Board's approval of placement of utility lines (poles, pipelines, telecommunication lines or power lines) within the County right-of-way at the following location, to-wit:

Starting approximately 3030 feet North of the SE Corner of Section 18, Township 6 NORTH, Range 17 ECM, a proposed buried cable to be placed along the East Right-of-Way of Section 18, Township 6 North, Range 17 ECM for approximately 520 feet. Starting at the SW Corner of Section 4, Township 5 North, Range 17 ECM, a proposed buried cable to be placed south across county Road F and along the West Right-of-Way of Section 9, Township 5 North, Range 17 ECM for approximately 3,775 feet. Starting approximately 1,515 feet west of the NE Corner of Section 5, Township 5 North, Range 15 ECM, a proposed buried cable to be placed east for approximately 1,515 feet to the NW Corner of Section 4, Township 5 North, Range 17 ECM. At this point, cable and a bore will be placed across county Road E from North Right-of-Way of Section 4, Township 5 North, Range 17 ECM to the South Right-of-Way of Section 33, Township 6 North, Range 17 ECM. Cable will extend from the NW Corner of Section 33, Township 6 North, Range 17 ECM along the North Right of Way of Section 33-Township 6 North, Range 17 ECM for approximately 5,280 feet to the NE Corner of Section 33, Township 6 North, Range 17 ECM. At this point a bore and cable will be placed from the SE Corner of Section 33, Township 6 North, Range 17 ECM to the SW Corner of Section 34, Township 6 North, Range 17 ECM, All cable to be placed approximately 4 feet off of Right-of-Way, if possible.

WHEREAS, petitioner must meet all requirements of the permit.

THERFORE, BE IT RESOLVED, the Board of County Commissioners of Texas County, Oklahoma, do hereby consent to the placement of a distribution line according to the requirements as set forth in the completed Permit Application attached. With the following special instruction to be included:
